- The Applicant does not have negative equity
- The Applicant is not in bankruptcy or liquidation proceeding
- The Applicant is regularly paying its obligations towards employees and has no outstanding debt for social contributions
- The Applicant is regularly paying due taxes to both local and national tax offices
- The bank accounts of the applicant were not blocked due to the unpaid obligations for a period longer than 40 days during the year 2018 and 2019
- The owner(s) and responsible persons /legal representatives of Applicant have not been criminally convicted
- The Applicant has not been issued with prohibition of performing their activities within two years before submitting the application
